Tina had forms to be signed for the CDBG application which was approved in May. A resolution to proceed with the grant was presented and Jeff made a motion for the President and Clerk to sign resolution 2025-2 with a 2nd by Carrie.

CCMG – Grant to micro seal the streets. Maureen reviewed the forms with Clerk and all were signed.

Waste Water Treatment Plant (WWTP)- Subcontractor - Scott Schutte-zoomed in

Scott Reported that the system is running well

Chlorine pump is acting up – found a replacement head to repair

Alarm systems delivered – will install in the next few seeks

Will track pumping hours that will help detect leaks

Had 2 violations on clhorine-declhor system, pump wasn't delivering the correct amount

Ordered dechlor which was delivered and chlorine which was not delivered

Public comment - Terry Hillis brought up cleaning up the old Huffer property. Marshal has left message with Son about clean up – Marshal will start 10 day notice.
